### Buy-sell spread

The buy-sell spread represents the difference between the entry and exit price and is an additional cost to investors that is generally incurred whenever they invest in or withdraw from the fund. The buy-sell spread is retained by the fund (it is not a fee paid to Pandal) and represents a contribution to transaction costs incurred by the fund such as brokerage and stamp duty, when the fund is purchasing and selling assets. Generally, half of the total buy-sell spread represents the buy spread and half the sell spread (as shown in the brackets above). There is no buy-sell spread on distributions that are reinvested.
