

# A Guide to Using BPAY®

## For existing investors making additional investments in Pental funds

Using BPAY® provides a secure, convenient and flexible way to invest:

- ▶ You can 'top up' your existing investment in a Pental fund without the need to complete an Additional Investment Form or send an instruction.

### A Who can use BPAY® to invest?

Existing investors can use BPAY® to add to their investment in a Pental fund they currently hold.

BPAY® is available as a method of payment in the online banking portals of most Australian banks and financial institutions. We recommend that you contact your bank or financial institution to confirm that you can use BPAY® to make a payment from your account or if you are unable to locate BPAY® in your online banking portal.

### B How to use BPAY® to invest?

- Step 1** ▶ Log in to your bank or financial institution's online banking portal and select the BPAY® option.
- Step 2** ▶ Enter the BPAY® Biller Code for the Pental fund you would like to invest into. The Biller Codes for the Pental funds are provided below in **section C** of this Guide.
- Step 3** ▶ Enter your unique 16 digit Customer Reference Number (CRN) — this is different from your Investor Number. Refer to your latest Pental Application Confirmation to obtain your CRN or contact us on **1300 346 821**. For existing investors you can find your CRN on the online web portal if you are registered or call Apex to request this.
- Step 4** ▶ Enter the amount you would like to invest.
- Step 5** ▶ Record the receipt number provided for your BPAY® transaction. Please keep this for your personal records. We will send you a transaction confirmation once your investment has been processed and units have been issued to you.
