## Ongoing annual fees and costs

The total ongoing annual fees and costs for each Fund comprises:

- management fees and costs
- transaction costs.

The estimated ongoing annual fees and costs shown in the current PDS include management fees, estimated management costs and estimated transaction costs (based on the previous financial year ended 30 June 2024). The following table provides updated estimated ongoing annual fees and costs for the financial year ended 30 June 2025. Except as otherwise stated, estimated costs are calculated based on our reasonable estimates of management costs and transaction costs using the actual costs incurred for the first 11 months in the previous financial year and annualising these actual costs for the 12 month period in the full financial year based on updated estimated management costs and updated estimated transaction costs reflecting the latest completed financial year ended 30 June 2025.

Ongoing annual fees and costs may vary in future years.

- 2 This is an estimate of indirect costs for the financial year ending 30 June 2025. These costs are reflected in the unit price of the Fund and are not charged to you as a fee nor retained by us. Where indirect costs are '0.00%', the Fund did not incur any indirect costs for the financial year ending 30 June 2025, although the Fund may incur these costs in the future.
- 3 This is the actual performance fee charged by the Fund for the financial year ending 30 June 2025. A performance fee is payable only if the Fund's investment return exceeds its performance return hurdle. Actual performance is likely to vary from year to year and therefore the performance fee will differ.
- 4 This is an estimate of transaction costs shown net of any amounts recovered by the Fund from the buy-sell spread incurred by transacting investors.

- 5 The Pendal Australian Long/Short Fund's performance fee for the year ended 30 June 2025 was 0.00%. The average annual performance fee charged in the Fund for the previous five financial years ended 30 June 2025 was 0.16%.
- 5 The Pendal Focus Australian Share Fund's performance fee for the year ended 30 June 2025 was 0.25%. The average annual performance fee charged in the Fund for the previous five financial years ended 30 June 2025 was 0.10%.
- 7 The Pendal MicroCap Opportunities Fund's performance fee for the year ended 30 June 2025 was 1.87%. The average annual performance fee charged in the Fund for the previous five financial years ended 30 June 2025 was 1.75%.
- 8 The Pendal MidCap Fund's performance fee for the year ended 30 June 2025 was 0.00%. The average annual performance fee charged in the Fund for the previous five financial years ended 30 June 2025 was 0.00%.
