## Target Market Summary

This Fund is intended for use as a **Major allocation, Core Component, Minor or Satellite allocation** within a portfolio for a consumer who is seeking **Capital Preservation or Income Distribution** and has a **Low** risk/return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with **No minimum investment timeframe** and who is unlikely to need to access their capital within **One week** of request.

### Investment products and diversification

## About the Fund

**Investment objective:** The Fund aims to provide a return (before fees, costs and taxes) that exceeds the Bloomberg AusBond Bank Bill Index.

**Product description:** The Fund is an actively managed portfolio of Australian cash and short term fixed interest securities.

The Fund is designed for investors who want capital stability, regular income from the short term money market and same day access to funds. The Fund predominantly invests in short term securities issued by Prime Banks or short term securities that we consider to have similar credit characteristics. The Fund also invests in a combination of

bank-backed, corporate and government short term money market and floating rate securities and annuities. The Fund aims to maintain capital stability through limited exposure to interest rate movements and prudent credit management. The Fund aims to maintain a stable \$1.00 unit price.

**Portfolio diversification:** The Fund is comprised of Cash and short term fixed interest securities 100%.

The Fund provides exposure to a broad range of Australian cash and short term fixed income securities. Its portfolio diversification has been assessed as Medium. Due to the Fund's Low risk profile and its stable \$1.00 unit price, the strategy is appropriate to be used as a Major allocation within a portfolio.

**Risk level:** Very low

A negative annual investment return may be expected for less than 0.5 years in every 20 years.

**Access to capital:** Under normal circumstances, withdrawal requests may be made on any Business Day and requests received by the Fund's cut off time on any Business Day will generally be processed on the following Business Day. A Business Day being a day other than a Saturday, Sunday or public holiday, on which banks are open for general banking business in Sydney. Withdrawals will generally be paid to your nominated Bank Account within 5 Business Days. Please refer to the PDS for full details on the withdrawal conditions for the Fund.

<b>Capital Growth</b>	The consumer seeks to invest in a product designed or expected to generate capital return over the investment timeframe. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
<b>Capital Preservation</b>	The consumer seeks to invest in a product designed or expected to have low volatility and minimise capital loss. **Consumer’s Risk (ability to bear loss) and Return profile for the relevant part of the portfolio**

This TMD uses the Standard Risk Measure (*SRM*) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the *Standard Risk Measure Guidance Paper For Trustees* (note the bands in the SRM guidance differ from the bands used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some products may use leverage, derivatives or short selling; may have liquidity or withdrawal limitations; may have underlying investments with valuation risks or risks of capital loss; or otherwise, may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.
